EVENT DATES

Boys' & Girls' 18s:

Qualifying will begin on Saturday, **December 4th** and end on **Sunday, December 5th**. All Qualifying play will take place at the Crandon Park Tennis Center.

Main Draw will commence on **Monday, December 6th** and conclude with the Finals on **Sunday, December 12th**.

Boys & Girls' 16s:

Qualifying will begin on **Friday, December 3rd** and end on **Sunday, December 5th**. Boys 16s Qualifying first & second round will take place Friday, December 3rd at the Crandon Park Tennis Center located on Key Biscayne. Remaining Qualifying play will occur at the Biltmore Tennis Center located in Coral Gables. All Girls 16s Qualifying will occur at the Biltmore Tennis Center located in Coral Gables.

Main Draw will begin on **Sunday, December 5th** and will end on **Saturday, December 11th**. Both Boys and Girls main draw first & second round matches will be played at the Biltmore Tennis Center

ENTRY DEADLINE

Entries for the 18s ITF must be submitted online prior to **Tuesday, October 26th 9:00am EDT** deadline through their IPIN number at www.itftennis.com/ipin.

Entries for the 16s must be submitted by the player's federation using the official Entry Form (see back page) and be received by the Dunlop Orange Bowl Championship in Boca Raton, FL, by 9:00am Eastern Daylight Time (EDT) **Tuesday, October 26th**. All 16s players must have an IPIN.

The entry deadline is the same for Singles (Qualifying and Main Draw) and Doubles. There are no Doubles-only entries. **Players may only enter into one age division.**

ELIGIBILITY

18 and Under:

Players must be born between January 1, 1992 and December 31, 1997.

16 and Under:

Players must be born between January 1, 1994 and December 31, 1997.

Players may not participate in either age division unless they have reached their thirteenth (13) birthday before the start of the main draw.

DRAW SIZE

18s and Under:

Qualifying: 64 boys and 64 girls. Eight boys and eight girls will qualify. Draws will be made Friday, December 3rd after sign-in closes.

Main Draw: 64 boys and 64 girls. Draw for the Singles Championship will be made Sunday, December 5th and posted online at www.dunloporangebowl.com after sign-in closes.

16s and Under:

Qualifying: 128 boys and 64 girls. Eight boys and eight girls will qualify. Draw will be made Thursday, December 2nd after sign-in closes.

Main Draw: 64 boys and 64 girls. Draw for the Singles will be made Saturday, December 4th and posted online at www.DunlopOrangeBowl.com after sign-in closes.

ALL DOUBLES ARE 32 TEAM DRAWS.

RULES AND REGULATIONS

The Rules, Regulation and Code of Conduct adopted and published by the ITF will govern all play. All Singles matches will be the best of three tie-break sets. Twelve point tiebreakers will be used at 6 games all in each set. Each doubles match shall be two tie-break sets and a match tie-break (10 point) in place of a third set. No-ad scoring will be used for Doubles. Default will be declared 15 minutes after the match is called.

Dress Code

ITF regulations mandate proper tennis attire. T-shirts are not permitted for boys or girls. Members of a dou-

HOSPITALITY
