



## USTA Texas Section W. T. Caswell Service Award

The W. T. Caswell Service Award, established in 1962, is given to the Texas resident who has made valuable contributions to the growth and development of tennis in Texas, working as a volunteer within the framework of the USTA Texas Section primarily at the section level over a period of years.

**What:** The USTA Texas Section continues the tradition of the United States Tennis Association by annually honoring a person who has made significant contributions to promote the game of tennis in the section by presenting its prestigious W. T. Caswell Service Award at the Annual Awards Banquet held during the Annual Meeting.

**Criteria:** The nominee must have worked as a volunteer within the USTA Texas Section framework for a period of years. The candidate must be recommended by at least two people familiar with the candidate's work. Nominators cannot be members of the candidate's immediate family. Among the criteria to consider are:

- Areas of volunteer work in community and section
- Depth of involvement in community and section (i.e. impact on overall tennis picture, number of years involved)
- New and innovative features resulting from candidates activities
- Involvement in other community service or recreational organizations
- Affiliation with United States Tennis Association
- Attend the USTA Texas Section Awards Banquet
- If selected, must provide a minimum of eight tennis related pictures for the banquet media production

**Award:** Recipient of the USTA Texas Section W. T. Caswell Service Award will be presented with an award at the Annual Awards Banquet held during the section's annual meeting. The recipient, if not a current member of a section committee, will receive compensation (mileage, 1 nights lodging and banquet tickets) for the immediate family.
