<sup>1</sup>Any junior may enter a Regular event, except in the ZATs. Only non-qualified juniors may enter the ZATs. Also, juniors may not play in the Regular division in the same age as their qualification, if their qualified division is offered and makes. Championship juniors may not "play up" in ZATs.

<sup>2</sup>In Championship Division, juniors who wish to play doubles should enter Regular doubles. In Championship Major Zones, at least one partner of each doubles team must be Championship qualified in the age division. Super Championship juniors may not "play up" in Championship Major Zones.

<sup>3</sup>Super Championship juniors must compete in Super Championship doubles if offered. At least one partner of each doubles team must be Super Championship qualified in the age division.

<sup>4</sup>Super Championship juniors may play up if 1) they are in their final twelve months of age eligibility in the younger age division, and if they were Super Championship qualified prior to the final twelve months of age eligibility in the younger age division, or 2) if they were endorsed in the younger age division to a USTA Super National Championship.
